## "DRAFT" NOISE ACTION PLAN ENVIRONMENTAL NOISE REGULATIONS, STATUTORY INSTRUMENT NO. 140 OF 2006

Meath County Council and Navan Town Council being the designated Action Planning Authorities under Article 7 of the above regulations, have prepared a "Draft" Noise Action Plan for the sections of major roads M1, M4, N2, N3 and R132, that experience a volume of traffic greater than 6 million vehicle passages per year, in their respective functional areas.
